**CA STATE CHAMPIONSHIP CANCELLATION POLICY** All cancellations must be submitted in writing to <u>mai@cheerpros.com</u> for review and confirmation.

Cancellations submitted in writing, received, and approved between September  $1^{st}$  – November  $30^{th}$ , will be eligible for a full refund of fees paid. Approved refunds will be issued by December 31, 2023.

Cancellations submitted in writing, received, and approved between December  $1^{st}$  –  $31^{st}$ , will be eligible for a refund of 50% of the fees paid. Approved refunds will be issued within 30 days after the event.

Cancellations submitted in writing, received, and approved between January 1<sup>st</sup> and January 29<sup>th</sup>, will not be eligible for any refund of fees paid. Fees are non-transferable.

# MEDICAL RELEASE & MEDIA APPEARANCE WAIVER

CHEERpros is going digital with our Medical Release & Appearance Waiver. We updated our process this year so that you entered your full team roster with the registration for the event. Once you complete your registration for the CHEERpros event, you will receive an e-mail confirmation that includes your *MEDICAL RELEASE & MEDIA APPEARANCE WAIVER LINK*. Please copy and paste the link to send to your Parents/Legal Guardians to complete for their competitor.

As Parents/Legal Guardians complete the online waiver, you will receive an e-mail notification for that competitor's waiver completion. We ask for your cooperation in keeping track of the completed waivers so that you can make sure that all athletes have completed waivers prior to the event (including alternates). Currently, you are unable to update your rosters in the system. If you need at add, delete, or change your roster, please contact Taylor Knox at taylor@cheerpros.com, and she will be able to assist you with the updates.

As a reminder, all athletes must have a signed online waiver completed to participate in any CHEERpros event. Waivers are no longer transferable from event to event; therefore, waivers will need to be completed for each event separately once registered.

## COLLEGIATE CHEER & DANCE TEAMS CERTIFICATE OF INSURANCE REQUIREMENT

Collegiate cheer and dance teams are required to have their liability insurance carrier add CHEER PROS LLC, as an additional insured for all CHEERpros Championships that the team(s) participate in. Please provide us with a certificate of insurance (COI) listing CHEER PROS LLC as the certificate holder, including the specific event date and venue location. Email your COI to <u>mai@cheerpros.com</u> no later than 30 days prior to the CHEERpros Championship that you will be competing at.

# **CIF SANCTIONED**

All CHEERpros Championships are CIF Sanctioned. Every Varsity Cheer Team must be a CIF registered program at their school to participate in any CHEERpros event.

The use of music, including sound effects, for any routine that your team plans to perform to must be properly licensed. All sound recordings used in your team's music may only be used with written license from the owner(s) of the sound recordings. Every Team is responsible and must obtain those licenses. Teams will be required to provide proof of licensing for every CHEERpros Championship Event and should be uploaded during the online registration. If you did not upload the documents during the online registration process, please e-mail your proof of licensing to <u>cheerprosdocs@gmail.com</u> no later than two (2) weeks prior to the event.
